





Health Nutrition & WASH

Accessible and affordable healthcare is the cornerstone of a healthy, productive, and fulfilling life. Yet, in many developing countries, access to essential health services, balanced nutrition, clean water, and basic sanitation remains a pressing challenge, particularly for poor and marginalised communities.

We believe that targeted investments in health, **nutrition, water, sanitation, and hygiene (HNWASH)**, especially for the **underserved populations**, can transform lives and generate sustainable impact. Aligned closely with the Sustainable Development Goal (SDG) 3 (Good Health & Well-being), our approach is a commitment to building **resilient health systems** capable of delivering **affordable, high-quality care for all**.

In partnership with National and State governments, development agencies, civil society organisations, private sector actors, and other stakeholders, **we strengthen health systems, improve supply chains, implement digital and AI-driven health solutions, and promote social and behaviour change**. We address **healthcare financing gaps** and work across the continuum of care—from **reproductive, maternal, newborn, child, and adolescent health, to non-communicable diseases (NCDs), communicable diseases** such as HIV, TB, and COVID-19, **pandemic preparedness**, and emerging threats like **antimicrobial resistance**. By integrating nutrition and WASH interventions with **innovative, technology-enabled solutions and One Health approaches**, we aim to create healthier and more equitable communities where everyone has the opportunity to live, grow, and thrive.




