# The Royal Norwegian Embassy - Norway India Partnership Initiative (NIPI)

2016-2018 (March), 2019 (July)-Ongoing

Established in 2006, NIPI was born out of an agreement between the Governments of Norway and India towards sustainable efforts to reduce maternal, newborn, and child (MNC) mortality in India.

**Project Type:** Technical advisory and implementation support

Over the years, NIPI has provided strategic, catalytic, and innovative support to India's National Health Mission (NHM) by testing scalable interventions in four high-focus states of Bihar, Odisha, Madhya Pradesh, and Rajasthan and the Union Territory of Jammu and Kashmir. We have been implementing the project since 2016-2018, and again from 2019.

Demonstrate innovative approaches to strengthening the health system for Sexual, Reproductive, Newborn, Child, and Adolescent Health.



### REPLICATE & SCALE

## Multi-donor | Sustainable Access to Markets and Resources for Innovative Delivery of Healthcare (SAMRIDH), India 2015 - 2025

SAMRIDH blends commercial capital with public and philanthropic funds to overcome barriers to private investment in market-driven health solutions, expanding access to affordable and quality healthcare for the vulnerable population.

**Project Type:** Technical advisory and implementation support

The initiative mobilised a capital pool of \$300 million to offer grant and debt financing provisions to healthcare enterprises and innovators, to augment the production and supply of high-impact health solutions for COVID-19. This was complemented by strong technical assistance and business advisory components to enable enterprises to make process and product improvements, navigate policy regimes, and build sustainability strategies for a long-term impact.

## Adaptive Impact Measurement and Learning for CDC Plus businesses as they navigate the Covid-19 Crisis 2021-2022

It was estimated that Covid-19 would result in at least US\$220 billion in losses in developing countries, with the impacts in Africa and Asia expected to be especially damaging. The impact on businesses was acute, forcing them to deal with unprecedented financial and operational stress. In response, CDC Group's technical assistance facility, CDC Plus, launched two new facilities – the 'COVID-19 Business Response Facility' and the 'COVID-19 Emergency Technical Assistance Facility' – to support up to 100 businesses it currently invests in to better respond to the pandemic and its effects, reaching an estimated minimum of 300,000 underserved people at this time of need.

IPE Global-subsiary Triple Line worked with both facilities to support learning, impact measurement and management.

## Consultancy Services to Support National and County Level Nutrition Resource Allocations, Budget Analysis and Expenditure Tracking, Kenya

2002-2003 to 2015-2016

We were responsible for documenting national level financial tracking, analysis and validation of financial resource allocations and expenditure for nutrition from the FY 2002-03 to 2015-16. We documented process comparing allocations to the actual expenditure and county level financial tracking and analysis for nutrition. We produced financial information packs and guidance note for nutrition budget tracking; and refined the financial tracking tool for nutrition and developing a user manual for application.

# USAID | SAMVEG: Systems Approach for MNCH Focusing on Vulnerable Geographies, India 2020 - 2025

Aiming to fill the critical gaps in the health sector, SAMVEG encouraged innovations, scale-up, and sustenance of interventions to improve maternal, newborn, and child health (MNCH) outcomes in identified vulnerable geographies of India. We supported monitoring and addressing bottlenecks for MNCH delivery in Jharkhand, Uttarakhand, and Madhya Pradesh. We also enhanced the capacity of state and district, public and private sector stakeholders to provide quality MNCH services.

## Conduct Child Protection System Mapping and Assessment, Bangladesh

2018-2019

The primary objective of this assignment was to undertake a thorough mapping and assessment of country level comprehensive child protection systems, laws, policies, services and procedures and capacities in place and to identify obstacles and opportunities in enforcing these laws and policies, especially in reaching vulnerable and excluded groups in Bangladesh.

We identified and analysed major strengths, weaknesses, gaps and opportunities in the current system; developed an analysis of information on the quality of services, coordination, measures and monitoring systems; assessed the government agency's perception, capacity and ownership to enforce the children's act which if properly resourced would contribute to strengthening of the child protection systems.

## Resolve to Save Lives (RTSL) | Swasthya Sankalp: A Holistic Approach to Hypertension and Diabetes Management, India

2024 - 2025

Launched in Gujarat, Maharashtra, and Karnataka, the project aims to strengthen CPHC services for effective hypertension and diabetes care, tackling India's high Non-Communicable Diseases (NCDs) burden.

We have implemented several critical interventions to strengthen hypertension and diabetes management, focusing on improving supply chain management, maintaining drug registers, conducting eAushadhi-based stock analysis, and accurately estimating drug requirements. We conduct regular NCD programme reviews, integrating key metric indicators and developing factsheets with district rankings. To strengthen the use of the NCD portal, we provide advocacy and hands-on support for real-time data entry, population and ABHA seeding, routine data analysis, and timely resolution of zero-data entries.

YAARI was conceptualised to shift the focus of India's Sexual and Reproductive Health (SRH) and Family Planning (FP) agenda from numeric targets to quality, choice, dignity, and empowerment, especially for adolescents and marginalised communities.

## Review of National Technical and Operational Guidelines under Family Planning 2025

Considering the rapidly evolving global landscape of family planning (FP) policies, technologies, and demographic needs, updating national FP guidelines periodically is essential. The "Review of National Technical and Operational Guidelines under Family Planning" was initiated to align existing frameworks with the latest global evidence, WHO recommendations, and national priorities, especially those linked to the FP2030 Partnership and SDG 3.

**Project Type:** Technical advisory

The review covered 20 technical, techno-managerial, and community engagement guidelines across five domains: accessibility, relevance, quality assurance, adaptability, and resilience. A secondary review was conducted with input from national experts via a structured questionnaire, yielding domain-specific scores followed by primary data collection through stakeholder consultations in six priority states, including Bihar, Delhi, Karnataka, Meghalaya, Uttar Pradesh, and West Bengal.



An advisory group meeting held in New Delhi on March 21, 2025, brought together over **40 subject-matter experts** to validate findings and propose policy recommendations based on relevance, scalability, feasibility, and acceptability criteria. The recommendations broadly emphasised **enhancing inclusivity, standardisation, youth engagement, and readiness of FP services through updated, user-friendly, and context-sensitive guidance tools.**

## DFID | Ethiopia Safe Space Programme (ESSP), Ethiopia 2016-2017

The project contributed to improved personal, social, health, safety, education, and financial outcomes for 2,000 adolescent girls in Amhara and Oromia regions of Ethiopia – building girls’ confidence, skills and knowledge as they progress through adolescence. ESSP was a pilot programme designed to test an approach for national scaleup. ESSP contributes to achievement of SDG-5 ‘Achieve gender equality and empower all women and girls’.

We completed the design of the programme, with the Federal Government of Ethiopia (GoE), (MoH, MoE, MoWCA) and other stakeholders, and developed an implementation plan for a nationwide Safe Spaces programme.

## Amref Health Africa | Health Systems Advocacy Partnership Project for SRHR, HRH & Family Planning, Kenya 2016

We undertook a baseline study for Amref Health Africa to support its regional agenda on strengthening Human Resources for Health (HRH) and Sexual and Reproductive Health (SRH) medicines and commodities. The study aimed to inform government adoption of effective, locally relevant policies aligned with international standards.

We developed the survey methodology, work plan, and detailed budget; conducted a desk review of project and policy documents; and prepared a comprehensive implementation plan to guide survey execution under the Health Systems Advocacy partnership.

The Government of Assam is implementing ASSIST to strengthen healthcare management and service quality across the State.

## Government of Kenya/ Kreditanstalt für Wiederaufbau (KfW) | End of Phase II Evaluation and Baseline for Phase III of the OBA Program, Kenya 2012

The Reproductive Health Output-Based Aid (RH-OBA) program in Kenya aimed to reduce maternal and neonatal mortality by improving access to quality reproductive health services for the poor.

Our firm evaluated Phase II (2008–2011) and conducted the baseline for Phase III, expanding to Kilifi and Kitui. Using OECD-DAC criteria, the evaluation assessed program relevance, efficiency, effectiveness, and sustainability, while identifying lessons and improvements. Baseline surveys in Nairobi, Kiambu, Kitui, Kisumu, and Makueni generated robust data to track future program performance.

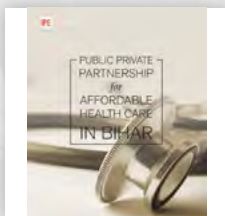
